A. Real Estate Description and Values. Real Estate is permanently listed, which means it is carried forward each year. We transfer ownership by Deed as of January 1 of each year. If property has been transferred by Will you must provide our office with a copy of the document.

B. Name and Mailing Address. Make corrections if information has changed.

C. Rental Property: for owners of Rental Houses and Rental Apartments only. Household Personal Property, (furniture, stoves, refrigerators, washers, dryers, window air conditioners) provided by a landlord is taxable in a rental unit or income producing property. Write in the number of items you provide and estimated value.

D. Personal Property: List aircraft by year, make, model and serial number. List boats by year, make, model, and length. Also, include hull number. List boat motors by year, make and horsepower, indicate if inboard or outboard. Motor Vehicles: UNLICENSED/PERMANENTLY TAGGED motor vehicles include cars, trucks, motorcycles, camping trailers, motor homes, boat trailers and utility trailers. You must provide name shown on title, year, make, model, body style and the complete Vehicle Identification Number (VIN). Without the VIN, we cannot accurately value the vehicle.
